## RANKING CLASSES

The tournament will be held in three ranking classes according to the Estonian ranking: **Women (unlimited)**, **Men 151+** (maximum 90 participants), **Men up to 150** (maximum 30 participants). The competition will be held as an individual tournament, after which the best team will be determined. Competitors must be at least 18 years old (born in 2007 and earlier).

## REGISTRATION AND ENTRY FEE

The tournament is open to anyone who is registered to compete by their employer. **Entry forms must be sent to [info@pingpong.ee](mailto:info@pingpong.ee) by 8 March 2026.** If you have any questions, please call Rein Lindmäe +372 502 3023 or email [info@pingpong.ee](mailto:info@pingpong.ee). An invoice will be sent according to the registration form. The player will be added to the list of participants after the entry fee has been received. The competition brackets will be prepared accordingly.

**The entry fee is €39, payable by 12 March 2026. Payment in person is not possible.**

## TOURNAMENT SYSTEM

Players are divided into sub-groups. The top two finishers in each sub-group will advance to the next round, which is a single-elimination round. Players who did not advance to the final round will also continue in a consolation bracket, which is also single-elimination. The exact system will be announced after the end of registration. The tournament starts at 10:00. A match is **played until three sets are won**, with each set played up to 11 points (2-point margin of victory). If competitors in a sub-group finish with an equal number of points, a head-to-head playoff will be the tiebreaker. If after the playoffs, there is still a circular tie between more than two players, the next tiebreaker is the number of sets won in head-to-head matches. If still tied, the winner will be determined by drawing of lots.

In addition to the individual competition, there will also be an inter-company competition, the winner of which will be declared the Estonian champion. The first place in the competition class will give the company 10 points; 2nd, 8 points; 3rd, 6 points; 4th, 5 points; 5th-8th, 4 points; 9th-16th, 3 points. The winner of the consolation round will give the company 2 points; all others will receive 1 point. **Points are therefore scored by all the competitors on each team.**

The official competition ball is **Mozuru 3-star** (ITTF approval, to be provided by the organiser).

## AWARDS

The three best players in each class will be awarded a medal. Medals will also be awarded to the top three in each class in the consolation tournament. The three best teams in the inter-company standings will be awarded a trophy. This will determine the Estonian Company Champion for 2026.

## GENERAL

Each participant is responsible for their own health. All matters not covered in the rules will be settled by the tournament referee Erik Lindmäe. **Entry fees are non-refundable in the event of withdrawal if the competition goes ahead as planned. Upon registering a team, the team representative confirms that they have read and accepted the terms and conditions.**

By participating, the player confirms that they have given their permission for the recording of his/her audio or video footage, the results of the competition and the personal data provided at the time of registration.

The player acknowledges that the above information will be publicly disclosed, transmitted to third parties and processed and confirms that it will not unduly prejudice the player's rights.

**The tournament is being held under the auspices of the Estonian Table Tennis Association. Part of the entry fees will be used to support the Estonian table tennis youth teams.**

**The competition will take place in accordance with procedure in force in the Republic of Estonia on the day of the competition.**
